

# COOKIE POLICY

In compliance with Directive 2009/136/EC, implemented in our legal system through Article 22.2 of the Law on Information Society Services and Electronic Commerce (LSSIyCE), and following the guidelines of the Spanish Data Protection Agency, we provide detailed information on the use of cookies on our website.

ZK ID Labs A.G, hereinafter "The Company," owns and operates the application, hereinafter "Billion Application" <https://www.billions.network>, which uses cookies for various functionalities.

## 1. What Are Cookies?

A cookie is a file downloaded to your computer when accessing certain web pages. Cookies enable an application to, among other things, store and retrieve information about a user's or their device's browsing habits and, depending on the information they contain and how the device is used, they may be used to recognize the user.

The user's browser stores cookies on the hard drive only for the duration of the current session, occupying minimal memory space and not harming the computer. Cookies do not contain any specific personal information, and most of them are deleted from the hard drive when the browser session ends (known as session cookies).

Most browsers accept cookies as standard and allow users to enable or disable them in their security settings.

## 2. Types of Cookies

### According to the Entity Managing Them

- **First-party cookies:** These are sent to the user's device from a system or domain managed by the website owner and are used to provide the requested service.
- **Third-party cookies:** These are sent to the user's device from a system or domain not managed by the website owner but by another entity that processes the data collected through the cookies.

### According to Their Purpose

- **Technical cookies:** Enable users to navigate an application, platform, or website and use its various options or services, including those necessary for managing the application's operations and enabling its features and services.
- **Preference or personalization cookies:** Store information that allows users to access a service with specific characteristics that distinguish their experience from others, such as language preferences or the number of results displayed in a search.

- **Analytics or measurement cookies:** Allow website owners to track and analyze user behavior on linked sites, including measuring the impact of advertisements. The data collected is used to improve services based on how users interact with the site.
- **Behavioral advertising cookies:** Store information on user behavior obtained through continuous observation of their browsing habits, allowing the creation of a specific profile to display relevant advertisements.

### According to Their Duration

- **Session cookies:** Designed to collect and store data while a user accesses a website. They are typically used for storing temporary information, such as a shopping cart, and are deleted when the session ends.
- **Persistent cookies:** These remain stored on the user's device and can be accessed and processed for a defined period by the entity responsible for the cookie, which may range from a few minutes to several years.

## 3. Cookies Used in the Application

The cookies used in this application are categorized as necessary and non-necessary. The use of non-necessary cookies requires user consent. These cookies help maintain session functionality or track user behavior to improve the application.

### Necessary Cookies (2):

### Non-Necessary Cookies (3):

reCAPTCHA	Google	Protect the application from spam and abuse by analyzing user behavior	-
